National School Deworming Day (NSDD)

- This is to remind all school heads on the conduct of National School Deworming Day (NSDD) –Round 2 on January 27, 2016 throughout the country.
- In consideration of the wide coverage of this activity, DOH staff, health workers from all health centers and hospitals of the Local Government Units nationwide are requested to provide assistance in deworming children in their jurisdiction.
- 3. The following activities are therefore expected to be done in every school before the conduct of deworming to maintain the habit of hygienic practices and secure protection from illnesses causing diarrhea, abdominal pain & undernutrition:
  - a. Washing of hands before eating (before recess).
  - b. Taking of deworming drug after a full stomach.
  - c.Toothbrushing Drill.

4. All enrolled children in public elementary schools shall be simultaneously dewormed by the class advisers (designated Mass Drug Administration Provider/MDAP), to be assisted by community health teams, supervised by CHO personnel for any case of a sudden adverse event like allergy.

Private schools are also encouraged to simultaneously conduct their own deworming activities after having coordinated with the division focal point person.

5. Each school shall have 1 NSDD point person responsible for collection of reports.

Forms shall be accomplished by the designated MDAP/Class Adviser.

Records & consolidated report of each grade level shall be collected by the grade chairman and submitted to the school principal. The principal shall submit the reports to the division office duly noted by the district supervisor.

The Schools Division Superintendent shall collect reports and submit it to DepEd Regional Office.

Records and reports shall be sent via text message for unofficial reports to tinyurl.com/deworming form-dagupan city at 11 o'clock in the morning of 27 January 2016.

Final and duly signed records and reports plus 1 wallet-sized documentation paper per school shall be submitted to division office after three (3) working days from the conduct of NSDD.

6. Remember that our target is 85%, if not more than, of the entire school populace.

Gather information and reason behind missed deworming.

For pupils dewormed by private practitioner, LGUs and others, secure certification and include in your data as a dewormed pupil.

All certificates however should be submitted to the division office.

- 7. The number of school children with signed permits should be submitted to the division office on or before December 15, 2015 as our basis in releasing the # of drugs needed by each school.
- 8. Strict compliance is hereby enjoined.
