



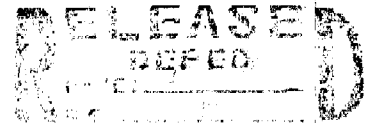



Subject: **Division Youth Leadership Training Camp 2018**

1. The Schools Division Office through the Youth Formation Unit (YFU) will be conducting the **Division Youth Leadership Training Camp 2018** at Romanz Hotel, Alaminos City, Pangasinan on **May 21-22, 2018** with the theme "**Functional Skills Building: Key to Effective SSG/SPG Governance (Phase 1)**".
2. The activity aims to develop and strengthen the leadership competencies of pupils and students, so that they effectively run the student government and implement programs, that will make an impact not only to their co-learners but to the school and outside the community.
3. Participants to this Leadership Training are the officers of Supreme Student Government and Supreme Pupil Government in public and private elementary and secondary schools. The registration fee of one thousand five hundred pesos (Php1,500.00) shall be used to defray the cost of food (3 snacks, 1 dinner on day 1, 1 breakfast, 1 lunch on day 2), t-shirt, supplies, accommodation, transportation and other incidental expenses. Registration of participants shall be from **April 24 to May 2, 2018**. List of participants should be submitted by the SSG/SPG Advisers to the Youth Formation Coordinator at the Division Office. Registration fee shall be charged against SSG/SPG Funds and donations/solicitations from benevolent stakeholders.
4. All SSG/SPG teacher-adviser participants are eligible for the grant of service credit pursuant to DepEd Order No. 53, s. 2003.
5. Enclosed is the Parental Consent to be signed by parents/guardians of participating pupils and students.
