

**TEACH FOR THE PHILIPPINES SUMMER LEARNING PROGRAM**

1. Teach for the Philippines (TFP), a for-purpose, non-stock, non-profit organization that works to provide all Filipino children with access to relevant and excellent education, will conduct its annual **Summer Learning Program (SLP) in Dagupan City from May 2 to 12, 2018.**
2. The SLP aims to promote school readiness in incoming elementary level students through a two-week intensive enrichment classes in the following subjects: Language, Math, Science and Values.
3. Two schools have been selected to **host** the program: **West Central Elementary School I and East Central Integrated School.**
4. The program is open to all incoming Grade 1 to 6 pupils who are enrolled for the coming School Year 2018-2019 in the following schools:
  - West Central Elementary School I
  - West Central Elementary School II
  - Juan P. Guadiz Elementary School
  - East Central Integrated School
  - Tebeng Elementary School
5. To register for the program, parents must sign the attached response form and activity waiver and submit them to their child's school by **April 6, 2018. Limited slots are available.**
6. Simple snacks and school supplies will be provided to the learners during the course of the program. Parents are requested to cover the transportation cost of the learners to and from the school.
7. Teachers who may be asked to assist with the logistical arrangements for the program will receive tokens from Teach for the Philippines in the form of honoraria, simple snacks and instructional materials.

I am aware of these risks of participation and I hereby acknowledge and understand that Teach for the Philippines has advised me to seek health and accident insurance in effect and that no such coverage is provided for me by Teach for the Philippines. *I know, understand, and appreciate the risks that are inherent in the above-mentioned activity. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.*

**Hold Harmless, Indemnity and Release:**

In consideration of my participation in these activities, I, for myself, spouse, heirs, personal representatives, estate or assigns, agree to defend, hold harmless, indemnify and release Teach for the Philippines and its officers, employees, staff, agents, and volunteers from and against any and all claims, demands, actions, or causes of action of any sort on account of accident, loss and/or damage to personal property, personal injury, sickness or death which may result from my participation in the above-mentioned activity.
