RE: REITERATION OF THE CONDUCT OF THE QUARTER 2 NATIONWIDE SIMULTANEOUS
EARTHQUAKE DRILL (NSED) CY 2018

DATE: 7 June 2018

1. Please be reminded of the **Conduct of the Quarter 2 Nationwide Simultaneous Earthquake Drill (NSED)**, scheduled on **June 21, 201, 2 o'clock pm in the afternoon** (as communicated in the **Division Memorandum No. 33, s. of 2018** and **Division Memorandum No. 126, s. 2018**, also attached hereto).
2. This is also in connection to the **DepEd Order No. 48, s. 2012**, stipulating that all public and private schools, and DepEd offices and attached agencies are encouraged to undertake the Quarterly Conduct of the National School-Based Earthquake and Fire Drills. The policy aims to generate the highest level of awareness among the public on Disaster Risk Reduction/ Climate Change Adaptations (DRR/CCA) concerns and to assess the capacity level of the school and the community in the eventuality of disasters and emergencies.
3. All public schools are hereby instructed to invite the Barangay DRRM Council and other Partner stakeholders/ agencies to help during the Post-Evaluation Activity, and identify areas of concerns and plans for action after the event. The Division will help coordinate with DRRM partner agencies for augmentation of Evaluators for the activity in the school.
4. There should be no deployment of the SDO Dagupan Personnel during the week of June 18-22, 2018 to give way to the ISO Internal Audit of all Units in the Division, though schedule of Capacity Building and SDO Dagupan Drill will be on Quarter 3 2018. As to such, all **Public Schools District Supervisors and School Heads are advised to ensure that schools are to comply with the conduct of the said activity, with Post-Evaluation and proper documentation of Q2 NSED 2018.**
5. Schools are expected to fill-up the **Q2 NSED Data report (google form)** to be sent thru email courtesy of Mr. Reynante Infante, SDO Dagupan ICT. While all Q2 NSED Activity reports, both hard and e-copy, shall be submitted to the through the SDO Dagupan DRRM Service at marjorie.rodriguez001@deped.gov.ph for consolidation on or before **June 22, 2018, 12 o'clock noon**. Please refer to the Q2 NSED report template attached hereto.

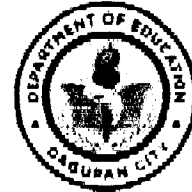

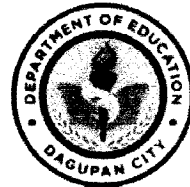
