RPMS Cycle for School Heads for SY 2018-2019

DepEd Order No. 2, s. 2015 provides for the guidelines in the implementation of the Results-Based Performance Management System (RPMS) for the Department of Education. All school heads/principals and Officers-in-Charge are required to prepare Office Performance Commitment Form (OPCRF) while department heads shall prepare their respective IPCRF's.

Alongside this issuance on Performance Management, all school heads shall adhere to the attached timelines to prevent cramming in the later part of the school year. As a system, the RPMS has to be done step by step.

The attached RPMS Cycle for School Heads/Principals should be included in the School Calendar for S.Y. 2018-2019 for the smooth implementation of RPMS, phase by phase.

All principals/school heads should also come up with their schedule of activities for the performance evaluation of their teaching and non-teaching personnel, following the guidelines specified in DepEd Order No. 2, s. 2015.
