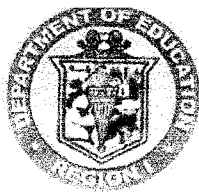

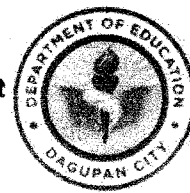



All assigned School DRRM Coordinators/Teacher-In-Charge shall ensure close coordination and monitoring in their respective areas with our DRRM Partner Agencies (BFP/CDRRMC/PANDA/PNP/Division Emergency Health Services) and Community Stakeholders (Barangay DRRMC/Security force) in case of incident, to ensure the necessary response intervention and appropriate action relative hereto.

In view of the preparations being done to ensure safety and security in all billeting schools which coincides on Saturday and Sunday, together with the reporting/coordination and monitoring and duty during the conduct of the RFOT which will extend working hours, all the above-mentioned personnel, together shall be entitled to service credits in accordance with DO 53 s., 2003 for teaching personnel and Compensatory –Time Off (CTO) for non-teaching personnel as per CSC & DMB Circular No. 2, s. 2004.
