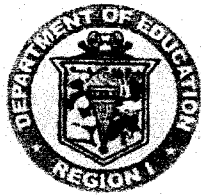

Subject: **Early Registration for SY 2019 - 2020**

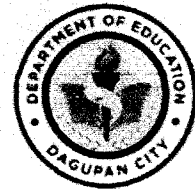
Date: January 21, 2019

1. The **Early Registration** generally aims to achieve the Sustainable Development Goal 4 which is on Quality Education primarily on ACCESS and is also in consonance with the DepEd battle cry Education for All (EFA). As per **DepEd Order No. 25, s. 2018** entitled **School Calendar for School Year 2018 – 2019**, the **Early Registration for Kindergarten to Grade 12** will commence on January 26, 2019 and will end on February 27, 2019.
2. Therefore, all public elementary and secondary schools are required to observe the activities intended for the early registration. For the activities in support of early registration and the registration process, please refer to **DepEd Order No. 6, s. 2017** entitled **Multi-Year Implementing Guidelines on Early Registration**.
