May I earnestly request your support and cooperation in the submission of entries to the "**Kurit Panlunggaring**", a literary writing contest in the Pangasinan language which is one of the highlighted features of this year's Agew na Pangasinan, with awarding ceremonies to be held on April 5, 2019.

Now on its seventh year, this literary contest generates entries for **Poetry, Children's Story, and Short Story under the Adult Division, and Poetry and Essay categories under the Youth Division**. There shall be top three prizes in all contest categories under each division, the winners of which will be awarded with cash incentives and trophies.

Teachers and students with prolific writing skills in the Pangasinan language from your academic institution are encouraged to join the various contest categories.

This contest was envisioned to help develop and sustain Pangasinan literature by providing incentives for our professional and aspiring writers to craft their most outstanding literary works in their native language. With this, the thrust is also to produce more Pangasinan literary works.

Attached please find the Guidelines and Entry Forms which may be photocopied/reproduced.

All entries should be submitted to the Kurit Panlunggaring Secretariat, Provincial Tourism and Cultural Affairs Office (PTCAO), 1st Floor Malong Building, Capitol Complex, Lingayen **on or before March 15, 2019**.

7th LITERARY AWARDS in the PANGASINAN LANGUAGE
Poem, Essay, Short Story and Children's Story Writing Contest

GUIDELINES AND RULES OF THE CONTEST:

1. The contest is open to all writers in the Province of Pangasinan, except those of the organizers, the judges and their immediate kin. **Deadline for submission** of entries is on **March 15, 2019**.
2. Entries must be original (not translated from other languages); have not won a prize in other contests; published and produced works can be entered in the contest.
3. There are four (4) contest categories and two (2) divisions, namely: Poetry Writing, Essay Writing, Short Story Writing, and Children's Story Writing; and Youth Division and Adult Division, respectively.
4. There shall be Poetry and Essay Writing categories for the Youth Division (below 18 years old). For the Adult Division, there shall be three contest categories namely, poetry, short story and children's story writing. All entries must be written in the **Pangasinan language**.
5. The theme is open and free, except for the Essay Writing, under the Youth Division. The theme for the essay writing, for this year's contest, shall be "**Yaman na Kulturang Tawir, Biskëg na Pangasinan.**" The writer shall write about the rich culture of Pangasinan and how it helps in strengthening the province.
6. Authors can submit two (2) separate entries in each contest category.
7. For the **Poetry Writing category**, the entry must be a collection of 8 to 10 poems. Each poem must not be less than 10 lines, but not more than 25 lines; and must be typewritten, single spaced or computerized in font size 11, font style Arial on a short bond paper (8.5" x 11" bond paper).
8. For the **Short Story Writing category**, an entry must be at least ten (10), but not more than twenty eight (28), written pages. It must be typewritten, double spaced or computerized in font size 11, font style Arial on a short bond paper (8.5" x 11" bond paper), with approximately one (1) inch margin on all sides and the page number typed consecutively, e.g. 1 of 28, 2 of 28 and so on. The entry must include a one-page synopsis.
9. For this year, the short story should be a **LOVE STORY**.
10. For the **Essay Writing category**, an entry must be at least four (4), but not more than five (5), typewritten pages, double spaced or computerized in font size 11, font style Arial on a short bond paper (8.5" x 11" bond paper), with approximately one (1) inch margin on all sides and the page number typed consecutively, e.g. 1 of 5, 2 of 5 and so on. It must carry an original title.
11. For the **Children's Story Writing category**, an entry must be five (5) to seven (7) pages. It must be typewritten, double spaced or computerized in font size 11, font style Arial on a short bond paper (8.5" x 11" bond paper), with approximately one (1) inch margin on all sides and the page number typed consecutively, e.g. 1 of 7, 2 of 7 and so on. The entry must include a one-page synopsis. The topic is open and free.
12. All entries should be submitted in five (5) hard copies. **All sets of entry SHALL NOT BEAR any name nor pen name of the contestant. Only the title of the contest piece should be indicated.** Each entry must be accompanied with a sealed envelope containing a short biography of the author, bearing his/her name and address, the title of his/her entry and a 2"x 2" picture and cellphone/telephone number.
13. All entries should be accompanied by the Official Entry Form and Notarized Authorization Form, and Parental Consent Form, if applicable.
14. A "**Hall of Fame**" Award will be given to a contestant who has been a first place winner in any contest category for three consecutive years. As such, the contestant shall be exempted from

three (3) years upon receipt of said award. He/she shall receive a trophy and a cash prize of Ten Thousand Pesos (Php10,000.00)

15. The decision of the Board of Judges shall be final. In cases when it is discovered that the author is not the real creator of the winning entry or he/she has violated Rule No. 2 of the contest, the BOJ and the organizers have the right to retrieve the awarded prize and he/she shall be banned to participate again in any future literary contest of the provincial government.
16. Submitted copies of winning entries shall become and remain the property of the provincial government. Non-winning entries may be claimed by the authors not later than three (3) months from the date of announcement of winners.
17. Cash prizes and trophies await the winners. Non-winning authors shall be entitled to a certificate of participation. The cash prizes shall be as follows:

18. The names of the winners shall be **announced on March 29, 2019**. Awarding of prizes will be during the Commemorative Program of Agew na Pangasinan on **April 5, 2019**. All winners should be present to personally receive their award.

20. The provincial government reserves the right to designate the persons who shall constitute the Board of Judges in each of the contest categories. The decision of the Board of Judges shall be final.
21. The Board of Judges shall declare only one winner for each prize stipulated. There shall be no co-winners and/or splitting of the prize money. The Board of Judges shall have the discretion not to award any prize, if, in their judgment, no meritorious entry has been submitted.
22. All those who submitted entries are deemed to have accepted the rules of this contest, and agree to abide thereby.
