

Prom Night Royalties 2019 Contest Mechanics and Qualifications

A. Qualifications:

The Prom Night Royalties 2019 Contest is open to two (2) male and two (2) female applicants chosen by each school with the following qualifications:

- 1. Must be a bonafide student of the school which he or she will represent. Such school must be within the province of the participating CityMall branch.
- 2. Must be currently enrolled as a Grade 9 or Grade 12 (3rd year High School and 2nd year Senior High School) student.
- 3. Must be a Filipino Citizen.
- 4. Must not have any existing Talent Contract with any National or Local TV Network, or any product/brand carried by a direct competitor of CityMall Commercial Centers Inc., its holding company, DoubleDragon Properties Corp., or any of the tenants of CityMall.
- 5. Must not be:
 - a. an employee of CityMall Commercial Centers Inc., its holding company, DoubleDragon Properties Corp., affiliates or subsidiaries; or
 - b. related to an employee of CityMall Commercial Centers Inc., its holding company, DoubleDragon Properties Corp., affiliates or subsidiaries, up to the first degree of consanguinity or affinity.
- 6. Must not be:
 - a tenant or contractor providing services to CityMall Commercial Centers Inc., its holding company, DoubleDragon Properties Corp., affiliates or subsidiaries; or
 - b. related to a tenant or contractor providing services to CityMall Commercial Centers Inc., its holding company, DoubleDragon Properties Corp., affiliates or subsidiaries, up to the first degree of consanguinity or affinity.
- 7. Must not be a relative of the selected judges up to the third degree of consanguinity or affinity.

Violation of any of the abovementioned qualifications during the entire duration of this contest (March 7, 2019 until March 15, 2019) shall be a ground for disqualification.

B. Registration and other requirements:

The qualified applicant shall submit a duly accomplished Registration Form and Waiver Form and attach the following:

- 1. Photocopy of Birth Certificate
- 2. School ID of the Applicant
- 3. Certificate of Enrollment from the School Registrar where the Applicant is currently enrolled



2. Contest Proper

- 2.1. This segment is scheduled on March 15, 2019 (Friday) at 5:00 P.M. Call time shall be at 4:00 P.M.
- 2.2. This segment shall be composed of two (2) parts:
 - A. School Uniform
 - B. Formal Wear/Ball Gown

2.3. School Uniform Competition

- 2.3.1. The candidates shall begin the contest proper by showcasing their beauty, elegance, and pride through their school uniforms.
- 2.3.2. The score of each candidate shall form part of his/her individual total score (as stated in the criteria for judging below) to determine the Prom Night Royalties 2019.
- 2.3.3. Each candidate shall be judged individually.

2.4. Formal Wear/Ball Gown Competition

- 2.4.1. The candidates shall then continue by showcasing their beauty and elegance through their chosen formal wear/ball gown.
- 2.4.2. The parent or guardian of candidates should not let the candidate wear attires which are indecent, revealing, discriminating, or tends to favor a particular political group. The Organizers shall have the authority or discretion to stop a candidate while performing if the attire is considered as indecent or revealing in concurrence with a DTI representative.
- 2.4.3. The score of each candidate shall form part of his/her individual total score (as stated in the criteria for judging below) to determine the Prom Night Royalties 2019.
- 2.4.4. Each candidate shall be judged individually.

2.5 Criteria for Judging

4. Written consent from the School Principal allowing the Applicant/s to join this contest

The qualified applicant must place the application form, waiver form, and other requirements inside a short brown envelope. Submission of all requirements shall be from March 7, 2019 (Thursday) to March 8, 2019 (Friday), at the Administrative Office of the participating CityMall branch from 9:00 A.M. to 9:00 P.M.

Each candidate is required to attend the following activities:

- 2. Contest Proper March 15, 2019 (Friday)

Failure to attend any of the abovementioned activities shall be a ground for disqualification. Each schedule of activity shall be supervised by a DTI representative.

1. Reading of Mechanics and Guidelines for Prom Night Royalties 2019

- 1.1. This segment is scheduled on March 11, 2019 (Monday) at 5:00 P.M. Call time shall be at 4:00 P.M.
- 1.2. The candidate, together with his/her parent or guardian (for minors), shall be subject to an orientation to understand the mechanics, guidelines, segments and other information in relation to the contest.
- 1.3. Two (2) copies of the approved mechanics and guidelines shall be provided to each parent or guardian, which shall be signed after the orientation. One (1) copy shall be submitted back to the Organizers, whereas the other shall be kept by the parent or guardian for reference.
