

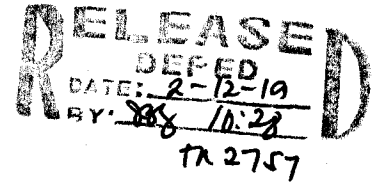

DISCUSSION FOR THE RPMS-PPST DIVISION REORIENTATION**

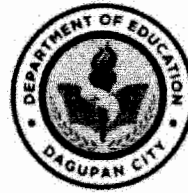

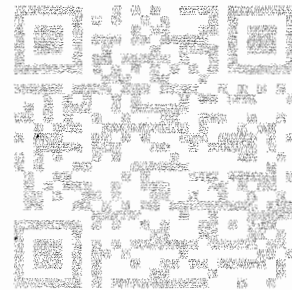
