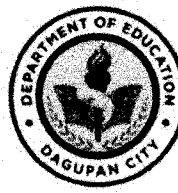

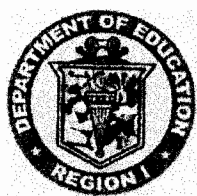

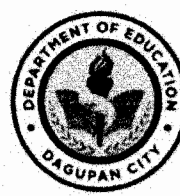

 - d. Workplan/Timelines & Cost Estimates
 - e. Plan for Dissemination
 3. Q & A follows after each presentation.
 4. Panelists from the Regional Research Committee Members/TWG
- 2) Also, **Technical Assistance will provided** by the Schools Division Office to the proponents through the SEPS on P & R and the newly-established TWG on Research Management on **Monday, March 4, 2019 at the E-Library. Proponents must bring their output during TA.**

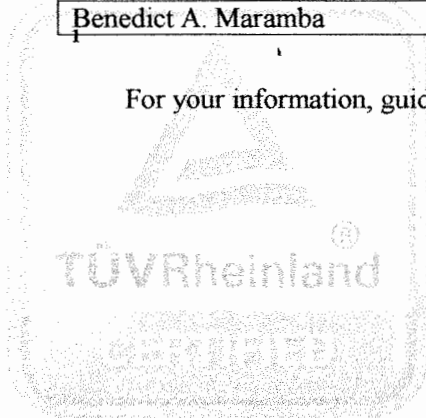
