- 1 In view of the strong partnership between the <u>SDO Dàgupan City and the Bureau of Fire Protection Dagupan City Station</u>, and in compliance with the **Dagupan City Ordinance Number 2136-2018** titled "Establishing a Junior Fire Safety Council in each Dagupan-Based Grade School", <u>all public and private schools shall establish and strengthen School Fire Safety Council for SY 2019-2020</u>
- The **Junior Fire Safety Council** (formerly called Junior/Kiddie Fire Brigade Council) will be undergo training on basic fire fighting, emergency medical response and rescue techniques, and shall serve as safety and resilience advocacy group, among the fellow students within their school.

  - b. Junior Deputy Fire Safety
  - c. Junior Secretary




