Subject: **ADMINISTRATION OF 2019 SPECIAL PHILIPPINE EDUCATIONAL PLACEMENT TEST (PEPT)**

Date: June 3, 2019

1. As per DepEd Memorandum No.048, s. 2019, the Department of Education (DepEd), through the Bureau of Education Assessment (BEA), with the assistance of Schools Division Office (SDO) of Dagupan City, will administer the **2019 Special Philippine Educational Placement Test (PEPT)** for free in commemoration of the 121st Celebration of Philippine Independence Day, on **Sunday, June 9, 2019, 7:30 A.M.** at **SDO, SGOD Office.**
2. **Test takers** are expected to be at the testing center before **7 o'clock in the morning**. They also have to be reminded of the required documents which include the following:
 - a. Registration Form
 - b. Photocopied Birth Certificate
 - c. ID Pictures- 2 pcs. identical and recently taken (size 1"x 1")
 - d. School Records (Form 137 or Form 138)
 - e. Copy of Government Permit/Recognition (for test takers from private schools)

Teachers who will serve during the administration of the PEPT shall be entitled to service credit in accordance with DepEd Order no. 53, s. 2003 entitled *Updated Guidelines on Grant of Vacation Service Credits to Teachers*. On the other hand, the non-teaching staff shall be provided with *Compensatory Time-Off (CTO)* per Civil Service Commission (CSC) and DBM Joint Circular No. 2, s. 2004 entitled *Non-Monetary Remuneration of Overtime Service Rendered*.
