Please be informed that this Office interposes no objection to the request of Child Evangelism Fellowship (Pangasinan District 4) to conduct EHSVEC that will be taught **once a week for 30 minutes per class in Elementary and 50 minutes in High School, during the students' vacant period not during the period of the Edukasyon sa Pagpapahalaga regular class.** However, the conduct of such activity shall be subject to the following conditions:

2. Regular classes shall not be sacrificed and that time on task shall be given the highest priority pursuant to DepEd Order No. 9, s. 2005 (Instituting Measures to Increase Engaged Time-On-Task and Ensuring Compliance Therewith);
3. Due diligence is likewise required to be observed by the proponents and the concerned school authorities at all times during the conduct of the activity.

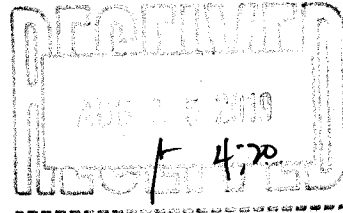


