**NATIONAL VALIDATION OF THE DRAFT PHILIPPINE PROFESSIONAL STANDARDS FOR SCHOOL HEADS (PPSSH) AND PHILIPPINE PROFESSIONAL STANDARDS FOR SUPERVISORS (PPSS)**

To : Schools Division Superintendents

1. The Department of Education – Bureau of Human Resource and Organizational Development (BHROD) and National Educators Academy of the Philippines (NEAP) shall conduct the National Validation of the Draft Philippine Professional Standards for School Heads (PPSSH) And Philippine Professional Standards for Supervisors (PPSS) on August 5-6, 2019.

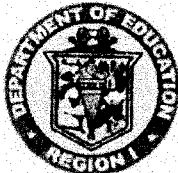
2. The activity aims to validate the competencies of the draft PPSSH and PPSS and to gather feedback from school heads and instructional supervisors.

3. Participants of the validation are incumbent school heads (i.e. Principal I to Principal IV) and supervisors (Chief Education Program Supervisors, Education Program Supervisors and Public Schools District Supervisors). Participants are randomly selected based on the sample size and criteria set by the RCTQ (*please refer to the attached list*).

4. The activity shall start at exactly 7:30 in the morning. There shall be provision of snacks and lunch for the participants. Breakfast and dinner will be served for those from the distant schools. Venue and accommodation shall be announced in a separate advisory.

5. Expenses such as transportation and other incidental expenses shall be charged against HRD funds, school MOOE subject to the usual accounting and auditing rules and regulations.
