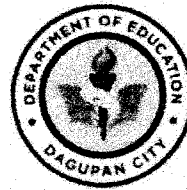


1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA), with the assistance of Schools Division Office (SDO) of Dagupan City, will administer the **2019 Philippine Educational Placement Test (PEPT)**, which will be announced until further notice.
2. Registration of applicants is **OPEN** and will be held in the Schools Division Office (SDO), Dagupan City at SGOD Office, SM Monitoring & Evaluation Unit c/o Mr. Isagani D. Rosario, Division Testing Coordinator (DTC). Deadline of application will be on **September 30, 2019**.
3. PEPT forms are available and a non-refundable fee of fifty (Php50.00) for regular examination shall be charged to each applicant.
4. Applicants should submit the requirements stated below when they register.
 - **Birth certificate:** Issued by the National Statistics Office (NSO) or Local Civil Registrar duly authenticated (original and two (2) photocopies)
 - **ID pictures:** Two (2) pieces of identical and recently taken (1×1" size)
 - **School records** (original and two (2) photocopies):
 - **Elementary Level** – Form 137 or Form 138
 - **Secondary Level** – Form 137
 - **Form 137 (Transcript of Records with school seal and signature of principal/registrar)*
 - **Form 138 (Report Card with school seal and signature of principal/registrar)*
 - **School permit:** Photocopy of School Permit to Operate/Government Recognition (for applicants from private schools)
 - **Registration fee** (non-refundable):
 - **Regular administration** (every November) – PhP50.00
 - **Walk-in/Special administration** – PhP200.00

5. Based on DepEd Order No.55, s. 2016 entitled **Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program**, the following may register for the PEPT:
- Learners from schools without government permit,
 - Learners from nonformal and informal education programs,
 - Learners who have incomplete or no record of formal schooling,
 - Learners with back subjects,
 - Learners who need grade level standards assessment, and
 - Learners who are overage for their grade levels.
