

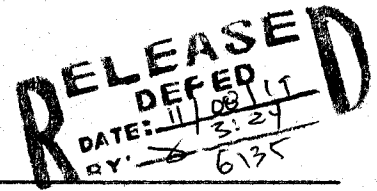
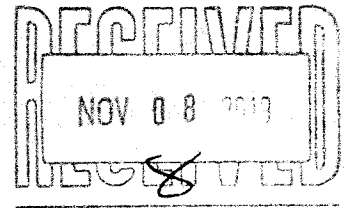

SUBJECT : COUNCIL SCOUT JAMBOREE 2019

1. We are pleased to announce the conduct of **2019 Council Scout Jamboree** with the theme **"Commitment to Excellence"** to be held on **November 15 - 17, 2019** at the Ramos' Farm (infront of BFAR) Bonuan Binloc, Dagupan City.
2. The jamboree aims to:
 - A. Seeks opportunities for young people to grow in all dimensions – physically, intellectually, socially and spiritually and to help them in the area of peace and human understanding;
 - B. Offers new ideas so that they are capable of taking active part in improving life in their local, national, and international communities.
3. The following are the guidelines to determine the contingent requirements:
 - A. All participants must be currently registered, must secure Medical Certificate and Parent's Permit and must be physically fit
 - B. A registration of eighty-five pesos (P85.00) shall be charged each Boy Scout/Senior Scout and thirty five pesos (P35.00) for each KAB Scout to cover the expenses for program materials, certificates, activity cards and other incidental expenses.
 - C. It is suggested that only handy and necessary equipment (tent,cooking gears, sleeping bags, food provisions, uniform, costumes, extra clothes, flashlight, personal toilet kit, first aid kit, etc.) should be brought by every contingent.
 - D. The delegates will take care of their own food provisions for the duration of the jamboree.
 - E. Transportation to and from the venue is the responsibility of every contingent.
4. Teachers are entitled to service credits depending on the number of hours they rendered services on Saturday and Sunday pursuant to DepEd Order No. 86, s. 2012 which reiterates DECS Memorandum No. 143, s. 1997 provides that service credits shall be granted for attendance in scouting activities. On the other hand, Non-Teaching Staff shall be provided with Compensatory Time-Off (CTO) as per Civil Service Commission and Department of Budget and Management Jointly Circular No. 2, s. 2004 entitled Non- Mandatory remuneration of Overtime Service Rendered.
