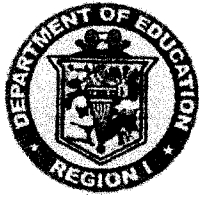
Accordingly, the following are required to be submitted by the BERF 2018 during the meeting:

- 2) **5 copies of complete and revised journal as per IMRAD Phase II for display during summit**

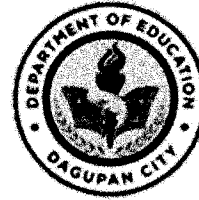

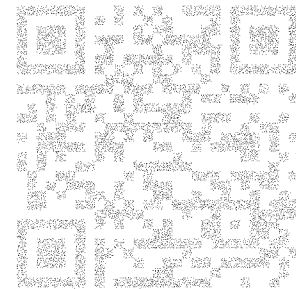
