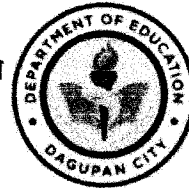

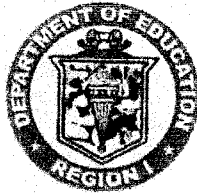
Subject: **DIVISION TRAINING-WRITESHOP ON MODULE DEVELOPMENT FOR GRADES 11 & 12**

Date: November 19, 2019

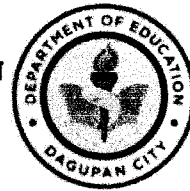
