3. Participants to the training are Grades 9 and 11 students from all public secondary schools of Dagupan City listed below:

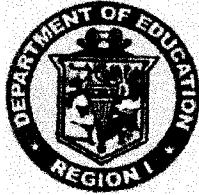

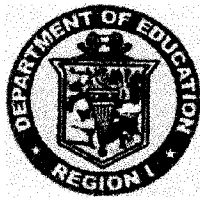

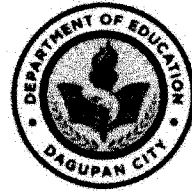
