**ANNOUNCING THE CONDUCT OF THE 2020
REGION 1 ATHLETIC ASSOCIATION MEET (R1AA)**

To: Schools Division Superintendents
School Heads, Public Elementary and Secondary Schools
School Heads, Private Elementary and Secondary Schools
All Others Concerned

1. Pursuant to the President's directive and DepEd Memorandum No. 15, s. 2020 and in consideration of the Resolution No. 139-2020 from the Pangasinan Provincial Board and the succeeding release of a signed public advisory dated February 13, 2020 by Honorable Governor Amado I. Espino III, declares the postponement of all scheduled public events and gatherings that are expected to draw large attendees or participants effective February 13 until mid-April this year.
2. Following these directives, this Office announces the conduct of the **2020 Region 1 Athletic Association (R1AA) Meet** which shall be conducted at the Narciso Ramos Sports and Civic Center (NRSCC), Lingayen, Pangasinan on April 13-20, 2020.
3. The 2020 R1AA Meet shall be hosted by the Provincial Government of Pangasinan and Schools Division Office 1 Pangasinan.
4. The R1AA Meet aims to:
 - a. Promote Physical Education and School Sports as an integral part of basic education for the holistic development of the youth for them to become responsible members of the community;
 - b. Foster to the youth the values of self-discipline, teamwork, and excellence;
 - c. Inculcate to the youth the spirit of sportsmanship, fair play and solidarity;
 - d. Promote inclusion and integration;
 - e. Promote and achieve peace through sports; and
 - f. Promote all other values inherent in sports.
5. Consistent with existing guidelines on classroom assessment, subject teachers are encouraged to give due consideration to learner-athletes in all quizzes, activities, performance tasks, on the dates that said learner-athletes are out on trainings or competitions.

6. The Regional Screening and Accreditation Committee (RSAC) is activated which shall be responsible for the interview, evaluation and verification of the authenticity of the documents submitted by the athletes, coaches and chaperons.

7. The evaluation and verification of documents of Athletes, Coaches and Chaperons (ACCs) shall be conducted at the National Educators Academy of the Philippines Region 1 (NEAP R-1), San Vicente, City of San Fernando, La Union on February 19-21, 2020.

8. The following policies shall continue to be enjoined and adhered to during the R1AA Meet:

- a. Child Protection Policy;
- b. Clean and Green and Eco-Friendly Policy; and
- c. No Smoking, No Liquor and No Gambling Policy

9. The sports events played during the 2019 R1AA Meet with its related general and technical guidelines shall remain in effect unless otherwise modified, revised or amended.



All coaches, chaperons, trainers, technical officials and other working committee members who shall render meritorious services during the conduct of the R1AA Meet shall be granted two (2) days compensatory time-off (CTO) for Non-Teaching Personnel and (2) days Service Credits for Teaching Personnel specifically for the following dates: April 18 (Saturday) and April 19 (Sunday).
