The Department of Education has released DepEd Order No. 007, s. 2019 which stipulates the conduct of end of school year rites not earlier than March 31 and not later than April 3, 2020. All concerned therefore should be guided by the following schedule of activities:

- Final Exam for Grades 6 & 12 – March 12-13, 2020
- Final Exam for Grades 1-5 & 7-11, 2020 – March 19-20, 2020
- Checking of Forms (School Clusters and Division level) – March 20, 2020

Checking of forms shall be a one-day joint activity to avoid mass gatherings and in answer to the call for localized response regarding COVID 19 infection prevention and control measures. Cluster heads therefore are advised to inform the division office on the cluster venues for the checking of forms.
