

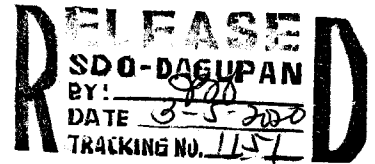

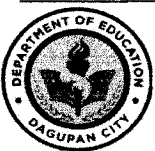

1.
