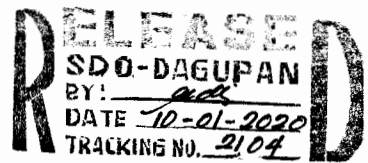

SUBJECT: **IMPLEMENTATION OF SCHOOL-BASED FEEDING PROGRAM (SBFP)  
– MILK FEEDING PROGRAM COMPONENT 2020**

**PARTICULARS**

1. Pursuant to Republic Act No. 11037 known as "**Masustansyang Pagkain para sa Batang Pilipino Act**" and DepEd Order No. 36, s. 2019 entitled, "**Guidelines on the Implementation of School-Based Feeding Program (SBFP)-Milk Feeding Program Component**", this office shall implement the School-Based Feeding Program (SBFP) – Milk Component targeting kinder to Grade 6 severely wasted (SW) and wasted (W) SBFP beneficiaries during FY 2019. Grade 6 are no longer included and shall be replaced by kinder entrants.
2. After reconsideration of the existing concern due to delays caused by COVID-19 pandemic, the School-Based Feeding Program (SBFP) – Milk Component shall be implemented on November 2020 (Second Batch) for at least 20 to 50 days to address the nutritional needs of the learners during the pandemic.
3. The program primarily aims to support the SBFP by providing fresh milk as supplement to the ready-to-eat food packs given to underweight learners, develop milk-drinking habit among the beneficiaries, improve nutritional status and address undernutrition and hunger especially during this COVID-19 pandemic.

The Schools Division Office, through Schools Governance Operations Division (SGOD) – School Health Section (SHS) shall endeavor to collaborate with the Philippine Carabao Center (PCC) Island Office for the delivery of fresh milk through a Memorandum of Agreement (MOA) including services for production, quality assurance, processing, packaging, logistics and delivery of fresh milk.
5. Relative to this, all elementary schools shall ensure the readiness to receive, handle and store the fresh milk which are packed in food-grade polyethylene pouches. An orientation shall be announced on a scheduled date to discuss various details of implementation, including its mechanics of delivery and receipt by the schools, timelines, storage, handling, accounting, risks management, forms, reporting and recording system, duties and responsibilities, monitoring and evaluation, among others.
