
**KNOWLEDGE LEVEL SURVEY ON FINANCIAL LITERACY



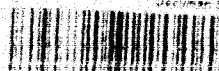
