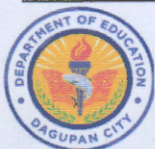

The purpose of this MOU is to define and outline the responsibilities between parties.


The Rotary Club of Dagupan East will provide a modular-type of a **HANDWASHING FACILITY** that will promote health service and proper hygiene of the school children.




