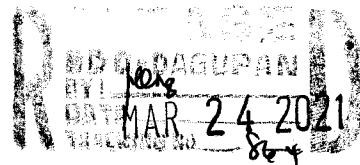

- Participants are also requested to bring a technical assistant who will be in charge of presenting the OPCRf and do the necessary editing in the document.

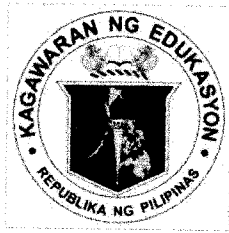
