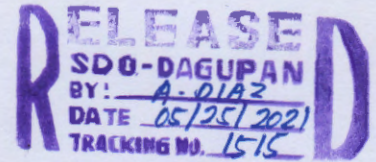

SUBJECT: CONDUCT OF THE NEUROPSYCHOLOGICAL ASSESSMENT

1. Manpower is the most important of all resources in an organization. With fully functional manpower, all other resources are taken care of and are enriched, leading to the excellent delivery of services. By fully functional, this means that personnel are mentally, psychologically, emotionally, physically and socially well, hence the needed for a responsive mental health program.
2. In light of this state of public health emergency and in response to republic Act No. 11036 (also known as Mental Health Law and DepEd Order 32, s. 2017: Gender Responsive Basic Education (GRBE), the Schools Division Office (SDO) aims to ensure the need of a continuous program that would cater to the mental health needs of its personnel. In line with this, an up-to-date/periodic assessment as a basis for intervention programs shall be in place.
3. In this regard, the SDO will conduct the **Neuropsychological Assessment** from **June 1-3, 2021**, that will be administered by the Wundt Psychological Institute, headed by licensed Psychologist, Dr. Nhorly U. Domenden.
4. The assessment will be done in three batches per day with a maximum of 18 participants per batch (see attachment for schedule), **observing the minimum health protocols and IATF standards**. Duration of the test will be 2 hours. All participants shall proceed to the **Wundt Psychological Institute, 2nd Floor**,
