WHEREAS, the Department of Education, Dagupan City Division is in need of a supplier for the PROCUREMENT OF IT EQUIPMENT FOR THE IMPLEMENTATION OF BASIC EDUCATION LEARNING CONTINUITY PLAN (BE-LCP);

WHEREAS, the Approved Budget for the Contract (ABC) which is funded by the Government of the Philippines (GOP)–General Appropriations Act (GAA) FY 2021 through the Department of Education is One Million Six Hundred Forty-Two Thousand Three Hundred Three Pesos (Php1,642,303.00);

WHEREAS, the BAC through its Secretariat posted the Invitation to Bid at the PhilGEPS portal with Reference No. <u>7649284</u>, at the Division website and at the conspicuous places of the Division Office on April 28, 2021;

WHEREAS, a Pre-Bid Conference was held on May 6, 2021 at the Conference Room, DepEd Dagupan City and was attended by observers and prospective bidders;

WHEREAS, the Submission and Opening of Bids was held on May 18, 2021 at the Conference Room, DepEd Dagupan City with One (1) bid proposal;

WHEREAS, only one (1) bid proposal passed the eligibility requirements after thorough examination of its technical and financial bid documents;

WHEREAS, the Technical Working Group (TWG) conducted a Detailed Bid Evaluation and Post Qualification Evaluation on May 20, 2021;

WHEREAS, on May 26, 2021 through BAC Resolution No. 2021-0003-A and No. 2021-003-B, the committee adopted and confirmed the TWG Detailed Bid Evaluation Report declaring ZYNNAH MITRADING as the bidder with the Least Calculated and Responsive Bid;

WHEREAS, the committee concluded to declare ZYNNAH MITRADING as the least calculated and most responsive bidder;

- 3) The completion of the works shall be made within <u>7</u> calendar days from date of receipt of the Notice to Proceed by the **Contractor** or the date provided for such purpose indicated in the Notice to Proceed;
- 4) In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 5) The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
