THIS AGREEMENT made this 13th day of May 2022 between the **Department of Education, Division of City Schools, Dagupan City** (hereinafter called the "Entity") **NUTRIDENSE FOOD MANUFACTURING CORPORATION** (hereinafter called the "Contractor").

WHEREAS, the Entity is ardent that the Contractor execute **Three Million Four Hundred Sixty Thousand Eight Hundred Sixty Pesos (Php 3,460,860.00)** (hereinafter called "the Works") and the Entity has accepted the bid for **Three Million Four Hundred Sixty Thousand Eight Hundred Sixty Pesos (Php 3,460,860.00)** by the Contractor for the execution and completion of the following Works and the remedying of any defects therein:

NUTRITIOUS FOOD PRODUCTS - SCHOOL-BASED FEEDING PROGRAM FY 2022

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1) In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2) The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) PhilGEPS Invitation to Apply for Eligibility and to Bid;
 - (b) Bid Data Sheet
 - (c) General and Special Conditions of the Contract
 - (d) Specifications;
 - (e) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (f) Eligibility requirements, documents and/or statements;
 - (g) Notice of Award of Contract and the Bidder's conforme thereto;
 - (h) Other contract documents that may be required by existing laws and/or the Entity.
- 3) The completion of the works shall be made within **30 days**.
- 4) calendar days from date of receipt of the Notice to Proceed by the **Contractor** or the date provided for such purpose indicated in the Notice to Proceed;
- 5) In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 6) The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

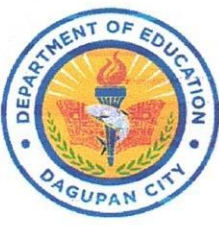
