## A RESOLUTION DECLARING LEAST CALCULATED RESPONSIVE BIDDER AND RECOMMENDING APPROVAL OF AWARD TO NUTRIDENSE FOOD MANUFACTURING CORPORATION FOR THE SCHOOL-BASED FEEDING PROGRAM (NUTRITIOUS FOOD) FY 2022

WHEREAS, the Department of Education, Dagupan City Division is in need of a supplier for the SCHOOL-BASED FEEDING PROGRAM (NUTRITIOUS FOOD) FY 2022;

WHEREAS, the Approved Budget for the Contract (ABC) which is funded by the Government of the Philippines (GOP)—General Appropriations Act (GAA) FY 2022 through the Department of Education is Three Million Four Hundred Sixty Thousand Eight Hundred and Sixty Pesos (Php3, 460, 860.00);

**WHEREAS**, the BAC through its Secretariat posted the Invitation to Bid at the PhilGEPS portal with Reference No. <u>8566838</u>, at the Division website and at the conspicuous places of the Division Office on April 4, 2022;

**WHEREAS**, a Pre-Bid Conference was held on April 12, 2022 at the Conference Room, DepEd Dagupan City and was attended by observers and prospective bidders;

**WHEREAS**, the Submission and Opening of Bids was held on April 25, 2022 at the Conference Room, DepEd Dagupan City with One (1) bid proposal;

**WHEREAS**, only one (1) bid proposal passed the eligibility requirements after thorough examination of its technical and financial bid documents;

**WHEREAS**, the Technical Working Group (TWG) conducted a Detailed Bid Evaluation and Post Qualification Evaluation on April 25, 2022 and May 5<sup>-</sup>2022 respectively;

**WHEREAS**, on April 26, 2022 & May 6, 2022 through BAC Resolution No. 2022-0001-A and No. 2022-002-B, the committee adopted and confirmed the TWG Detailed Bid Evaluation Report declaring NUTRIDENSE FOOD MANUFACTURING CORPORATION as the bidder with the Least Calculated and Responsive Bid;

**WHEREAS**, the committee concluded to declare NUTRIDENSE FOOD MANUFACTURING CORPORATION as the least calculated and most responsive bidder;

NOW, THEREFORE, we the members of the Bids and Awards Committee hereby resolve, as it is hereby resolved to recommend the award of contract to NUTRIDENSE FOOD MANUFACTURING CORPORATION for the NUTRIDENSE FOOD MANUFACTURING CORPORATION with the contract amount of Three Million Four Hundred Sixty Thousand Eight Hundred and Sixty Pesos (Php3, 460, 860.00).
