

- Pursuant to DepEd Order no. 32, s. 2011 and DepEd Memorandum No. 138, s. 2017, the Schools Division Office of Dagupan City issues this Policy Manual on Learning and Development of the Schools Division Office Dagupan City.
- 2. This Policy aims to:
 - Establish standards in assessing, planning, designing, delivery, monitoring, and evaluation of learning and development programs and activities across levels of governance involved within the division including the standards and outputs expected from the performance of the said process;
 - Provide professional development opportunities to help employees enhance their skills, knowledge, and attitudes to perform their duties and functions effectively and efficiently where gaps have been identified, performance reviewed and assessed, and eventually addressed;
 - Raise the quality, ensure relevance, and develop cost-effectiveness of knowledge, skills, and attitude;
 - d. Establish L&D roles, responsibilities, and coverage of the schools, learning centers, districts, sections, and units in the three (3) functional divisions of SDO Dagupan City; and
 - e. Encourage employees to participate in L&D PAPs and other lifelong learning programs for the benefit of the organization and for personal and professional growth and development.


