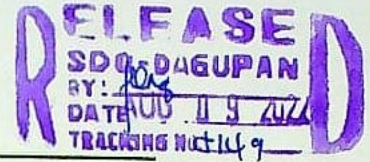

MANAGEMENT COORDINATORS and ALTERNATES
of the SCHOOLS DIVISION OFFICE of DAGUPAN CITY**

1. Pursuant to the Department of Education Order No. 21, series of 2015 on the "Disaster Risk Reduction and Management Coordination and Information Protocol," whose enclosure found in IV. DRRM Roles and Responsibilities wherein "The School Head may serve as the School DRRM Coordinator but shall appoint an alternate among other school personnel to assist in the implementation of Disaster Risk Reduction and Management (DRRM).
2. This omnibus certification on the designation of the School Disaster Risk Reduction and Management Coordinators and their Alternates, with the issuance of their certificates of designation shall take effect immediately upon approval, until three (3) years from its signing or until its termination.
3. The Disaster Risk Reduction and Management has twenty-three (23) training modules, making it unique and distinct from any other coordinators. Based on experience, SDRRM Coordinators cannot complete the 23 training modules if they are given only a year.

4. Trainings of a SDRRM coordinator includes: Philippine Basic Education System, Protection of School, Conflict Sensitive Education, Supplies and Logistics, Comprehensive DRRM Education, Contingency Plans in Basic Education, Skills in First Aid, Cardiopulmonary Resuscitation (CPR), Basic Firefighting Skills and Drills, Rescue, Psychological First Aid, Rapid Assessment of Damage Report (RADaR) and Post Disaster Needs Assessment (PDNA), Camp Management, Education in Emergencies, Climate Change Adaptation, etc.
5. The training of new coordinators yearly makes it expensive on the part of the Schools Division Office, the reason why a three (3) year term is requested.
6. The need for an Alternate Coordinator is also requested, so that training will be continuous and as successor, after the term of the SDRRM Coordinator designate.






