**SCHOOL YEAR 2022-2023** 

- 1. Attached is the Memorandum from the Office of the Assistant Secretary for Youth Affairs and Special Concerns (OASYASC) titled "Interim Guidelines of the Youth Commission for Elections and Appointments (Youth COMEA) for School Year 2022-2023". The Schools Division Office reiterated the conduct of Student Government Election on the first to second week of September 2022.
- 2. The SSG/ SPG Elections shall follow this indicative schedule:

September 5-16, 2022	School-Based SG Elections
September 23, 2022	Division SG Elections
September 26-30, 2022	Regional Federations Elections
Octover 7, 2022	National Federation Elections

3. All public elementary and secondary shall follow the Revised Interim Guidelines as stated in the said Memorandum.

The schedule of the conduct of the elections for student-led organizations such as Brigada Kontra Droga (BKD), Youth for Environment in Schools' Organization (YES-O) and other registered school clubs and organizations shall commence after the SSG/SPG Elections. Schedule shall be determined by the Youth COMEA.

Private schools offering K to 12 Basic Education Program are encouraged to implement these election and appointment guidelines according to their philosophy, vision and mission with the approval of their respective DepEd Regional Offices. Educational schools and institutions are allowed to contextualize the guidelines according to their mandates and own structure.
- Expenses incurred in the conduct of S.Y. 2022-2023 student organizations'
  elections shall be charged to the School Maintenance and other Operating
  Expenses (MOOE) or other available funds subject to the usual accounting and
  auditing rules and regulations.
