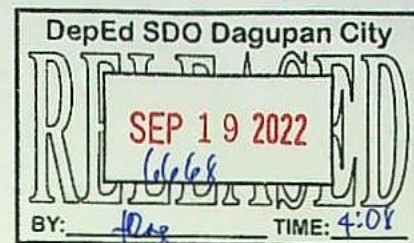

Subject: **INTERNATIONAL COASTAL CLEANUP DAY 2022**

1. Pursuant to *Proclamation no. 470, s. 2003* which recognizes the third Saturday of September as the observance of the International Coastal Clean-up Day, the Schools Division Office shall conduct a coastal cleanup activity at the Bonuan Tondaligan Beach on **September 23, 2022** from **6:00 to 7:30 a.m.** at the **Japanese Garden, Tondaligan Beach Park.**
2. SDO personnel, together with the Division Federated YES-O, Boy Scouts of the Philippines, the Girl Scouts of the Philippines, school heads, teachers, and other stakeholders are invited to join the coastal cleanup activity. Meeting place will be at the Japanese Garden, Tondaligan Beach Park. Participants are requested to bring their own cleaning gloves, cleaning materials, and trash bag.
3. Representatives from nearby schools may attend the cleanup activity at Tondaligan Beach. Schools from other districts are encouraged to conduct their own school or community cleanup in observance of this day.
4. Participation in this activity shall be on a **voluntary** basis and in accordance with the no-disruption-of-classes policy as stipulated on **DepEd Order no. 9, s. 2005** titled "*Instituting Measures to Increase Engaged Time-On-Task and Ensuring Compliance Therewith.*"
