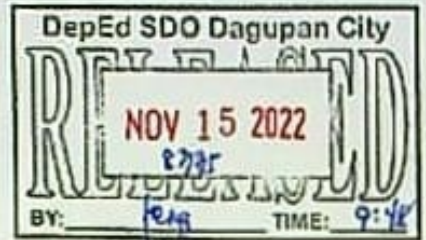

Subject: **DIVISION OBSERVANCE OF NATIONAL BREAKUP WITH SACHETS DAY - PLASTIC ATTACK IN SCHOOLS**

1. Pursuant to DepEd Order no. 34, s. 2022 titled "School Calendar and Activities for the School Year 2022-2023", the National Day for Youth in Climate Action is observed every November. In line with this, the Division Federated (DF) YES-O, SSG, and SPG, in collaboration with MakeSense Asia, shall conduct the National Breakup with Sachets Day - Plastic Attack in Schools on **November 16, 2022**.
