Subject: **DAGUPAN CITY DEVELOPMENTAL BASKETBALL/VOLLEYBALL LEAGUE**

1. This office expresses support in the conduct of the **DAGUPAN CITY DEVELOPMENTAL BASKETBALL/VOLLEYBALL LEAGUE TOURNAMENTS** as an important sports activity and project innovation geared towards strengthening the preparation for the SDO-DC ATHLETIC ASSOCIATION Meet 2023, R1AA and the Palarong Pambansa.
2. The activity will be separated from the regular activities of the Athletic Meet to give more time and opportunity for the players to harness their craft and form part of their training/preparation for the R1AA. Since the new policy for team events is "winner-take-all" and that the winning team/school will go directly to the regional meet. The tournament may end even a week before the Regional Meet. Thus, it serves as the actual training of the team as this really needs a longer time to be more beneficial and more competitive.
3. The events to be conducted are the following:
  - a) **Regular 5x5 Basketball:** Open to Elementary and Secondary for both boys/girls
  - b) **3X3 Basketball:** open to Elementary and Secondary both boys/girls and WHO ARE NOT members of the team playing for the 5X5 and a Special 3X3 Feature for Teaching and Non-Teaching personnel.
  - c) **Volleyball:** Open for both elementary and Secondary, boys and girls.
4. The project aims:
  - a. to attract and get into sports children/learners and youth instead of being hooked to gadgets or illegal acts;
  - b. to introduce and harness the basic skills and enthusiasm of the sport of basketball/volleyball;
  - c. to serve as the main training period for the champion teams;
  - d. to use the activity as an avenue to develop future marquee players and good citizen of their own school and community.

5. The activity will be conducted on Saturdays/Sundays/holidays and if necessary after class hours starting at 4:00pm, only when time to finish is not enough.
6. A minimal participation fee of P80/player (Volleyball) and for Basketball, P125/player (5X5), P50/player (3X3-learners) and P150/player (3X3-teaching/non-teaching personnel) will be charged to defray expenses to be incurred in the conduct of the said activity, and a modest contribution/share to sports development and aware of the difficulty being experienced by the local Government as regards the City Budget 2023. This is however on a voluntary basis or may opt to find a sponsor/benefactor.
7. The **FINAL MEETING** of Coaches shall be held on February 7 (Wednesday) at 2:00PM at the Division Training Center, SDO.
8. The **Opening Ceremonies** shall be on **FEBRUARY 26 (Sunday)**, the venue is to be announced. The tournament will run until April 15, 2023.
