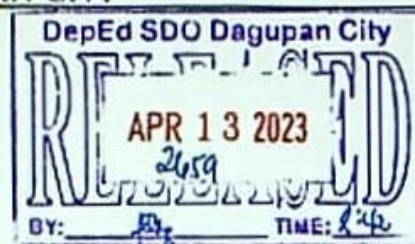



Subject: **CALL FOR SUBMISSION/UPLOADING OF LEARNING RESOURCES FOR
REGIONAL QUALITY ASSURANCE**

Date: April 11, 2023

1. In compliance to DepEd Memorandum No. 14, s. 2022 titled "*The DepEd Quality Management System (QMS) Manual and Procedures and Work Instructions Manual*," the Curriculum and Learning Management Division (CLMD) of the Regional Office aligned its core processes to those specified in the QMS Under Learning Resource Management is the sub-process called "Management of the Quality Assurance (QA) of Learning Resources (LRs)." Part of the quality control plans declared by CLMD along this sub-process is the call for submission of learning resources to be quality assured.
2. In view of the above, the Regional Office is calling for submission of any type of learning resources like interactive materials e-Strategic Intervention Materials, video-mediated LRs, instructional videos, explainer videos, learning activity sheets and other print LRs aligned to the competencies in the existing curriculum guides. These LRs will be subjected to further quality assurance by the Regional Quality Assurance Team. The outputs of this activity (findings and recommendations) will then be forwarded to the concerned development teams for appropriate action.
3. Validated final copies will eventually be submitted to the Management Team for approval of the publishing in the Region I Learning Resource Information System for Regionwide utilization or in the DepEd LR Portal.
4. To facilitate the submission and harvesting of LRs for QA, the schools are requested to submit the readily available LRs thru this link <https://tinyurl.com/LRDagRQA> on or before April 17, 2023. The School/SDO development and quality assurance teams of the quality assured LRs will receive Certificate of Recognition provided that the LRs meet the existing standards and guidelines on LR Development and Quality Assurance.
