

WHEREAS, the Submission and Opening of Bids was held on April 4, 2023 at the Division Training Center, DepEd Dagupan City with One (1) bid proposal;

WHEREAS, only one (1) bid proposal passed the eligibility requirements after thorough examination of its technical and financial bid documents;

WHEREAS, the Technical Working Group (TWG) conducted a Detailed Bid Evaluation and Post Qualification Evaluation on April 4, 2023 and April 17, 2023 respectively;

WHEREAS, on April 11, 2023 through BAC Resolution No. 2022-0004-A and No. 2022-004-B, the committee adopted and confirmed the TWG Detailed Bid Evaluation Report declaring ELMUEL JAY TRADING & CONSTRUCTION as the bidder with the Single Least Calculated and Responsive Bid:

CONTRACT AGREEMENT

THIS AGREEMENT, made this 24th day of April 2023 between Department of Education, Schools Division Office, Dagupan City (hereinafter called the "Entity") and ELMUEL JAY TRADING & CONSTRUCTION (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute LOT 4 CONSTRUCTION OF TEMPORARY LEARNING SPACES – BONUAN BOQUIG ELEMENTARY SCHOOL (hereinafter called "the Works") and the Entity has accepted the Bid for Five Hundred Thirty-Nine Thousand Two Hundred Fifty-Five Pesos and 13/100 (Php 539,255.13) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Five Hundred Thirty-Nine Thousand Two Hundred Fifty-Five Pesos and 13/100 (Php 539,255.13) or such other sums as may be ascertained, ELMUEL JAY TRADING & CONSTRUCTION agrees to LOT 4 CONSTRUCTION OF TEMPORARY LEARNING SPACES BONUAN BOQUIG ELEMENTARY SCHOOL in accordance with his/her/its Bid.
- The Department of Education, Schools Division Office, Dagupan City agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
