



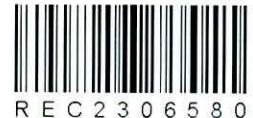

This has reference to the conduct of the **Writeshop for the Development of Training Session Guides for Skill-building on Addressing Child Labor Issues** by the Learner Rights and Protection Office (LRPO) on **June 20-22, 2023** at the **Bayview Park Hotel, Manila**.

The activity aims to contribute to the development of a skill-building program to capacitate the Regional Office (RO) and Schools Division Office (SDO) learner rights and protection focal persons on handling and responding to various child labor concerns affecting learners within their jurisdiction.

Specifically, at the end of the workshop, the participants are expected to:

- A. draft session guides for skill-building on addressing child labor issues;
- B. incorporate the United Nations Convention on the Rights of the Child, Philippine laws, and DepEd policies related to child protection and child labor in the session guides; and
- C. aid the RO and SDO focal persons in the construction of new knowledge about child labor and addressing child labor issues.

In view of this, we would like to request the participation of the following in the aforesaid activity:

- identified writers listed in **Enclosure 1**;
- one (1) regional learner rights and protection focal person per region, for a total of sixteen (16) regional learner rights and protection focal persons; and
- one (1) registered guidance counselor (RGC) from the regions identified in **Enclosure 2**, to be identified by the regional learner rights and protection focal person.

The identified writers were selected based on their previous engagement with LRPO as writers and trainers. The regions with RGC participants were selected based on the high incidence of child labor in those regions, as reported in the October 2019 and October 2020 Labor Force Survey of the Philippine Statistics Authority.

Travel expenses of the participants shall be charged against local funds, subject to the usual accounting and auditing rules and regulations. The Regional Offices and the Schools Division Offices are requested to augment any shortages on the funding requirements.
