# REMINDERS ON PARTNERSHIP EFFORTS AND ENGAGEMENTS AT THE SCHOOL LEVEL

To: Schools Division Superintendents
School Heads in Public Elementary and Secondary Schools

- 1. This Office reminds all school heads and teachers in public elementary and secondary schools to promote professionalism in the implementation and delivery of basic education programs and services (DepEd Order 47, s. 2022).
- School Heads, Teachers and other Officials and Employees are reminded to observe the following measures:
  - A. Refrain from seeking endorsement, recommendation, contribution, support, consideration, political accommodation, or any form of intervention from other government personnel or similar entities outside DepEd;
  - Desist from soliciting favorable actions from politicians to facilitate the implementation of programs, projects and activities, or activities, except those covered by the Adopt-A-School Program, initiated by the local government units, funded by the Special Education Fund (SEF), or covered by partnership agreements and/or allowed by law;
  - Cease posting on social media such as facebook and other publications of school needs especially during brigada eskwela; and
  - d. Follow partnership engagement protocols as set out in the partnership manual for school heads.
- As such, all partnership efforts and engagements at the school level should be done at the institutional level. Finding educational partners is the sole responsibility of the school heads.
- 4. All concerned should judiciously implement and deliver basic education programs and services.
