

YEAR 2023-2024 FOR PRIVATE SCHOOLS

In view of the opening of classes for School Year 2023-2024, private schools may begin operations earlier than public schools, provided that classes open on the 1st day of June but not later than the last day of August, as stipulated in Republic Act (RA) No. 11480 or an act amending Section 3 of RA No. 7797, otherwise known as An Act to Lengthen the School Calendar from Two Hundred (200) Days to Not More Than Two Hundred Twenty (220) Class Days.

Likewise, private schools must submit their school calendar to their respective regional offices to validate the requirements.
