EXPECTED PARTICIPANTS: All public and private secondary students (Junior High School and Senior High School) from the different Schools Division of Pangasinan and secondary schools with LINK Club

MECHANICS:

- 1. Each division may send a maximum of two (2) participant to represent their division (1 Junior High School & 1 Senior High School student). Each secondary school with LINK club may also send a participant. Participating school should be a member of the association.
- 2. The Province Wide Annual Essay Writing Contest should carry the theme "Mental Health Is A Universal Human Right"
- 3. Work must follow specifications inside:

Paper Size : A4
Font Size : 12
Font Style : Arial
Alignment : Justified

Margin : 1 inch all sides (Normal)

Spacing : Double Space

- 4. Essay must be in English. Maximum word count is Two Thousand (2,000), minimum count is 750.
- The name, school of the participant and division being represented shall be attached to the entry in a separate sheet of paper and must not appear in any part of the work.
- 6. Entries shall be judged on the following criteria:

MECHANICS:

- Each division may send a maximum of two (2) participant to represent their division (1 Junior High School & 1 Senior High School student). Each secondary school with LINK club may also send a participant. Participating school should be a member of the association.
- 2. The Province Wide Annual Poster Making Contest should carry the theme "Mental Health Is A Universal Human Right"
- 3. Any of the following may be used: crayons, craypass, pastel color, watercolor, pentel pen, pencil or charcoal and illustration board measuring 18 x 24 inches. Materials to be used will be provided by each participating division or participant.
- 4. All entries should be submitted on or before the deadline of submission.
- 5. Criteria for judging:

Relevance to the theme	30%
Originality	15%
Creativity	15%
Workmanship	20%
Visual Impact	20%
TOTAL	100 %

- Name, School and City/Province of the contestant must be written at the BACK OF EACH ENTRY so as not to disclose identity during the judging.
- 7. The decision of the judges is final.
