A RESOLUTION DECLARING SINGLE LEAST CALCULATED RESPONSIVE BIDDER AND RECOMMENDING APPROVAL OF AWARD TO NUTRIDENSE FOOD MANUFACTURING CORPORATION FOR THE IMPLEMENTATION OF SCHOOL-BASED FEEDING PROGRAM (SBFP) FOR FY 2023 (NUTRITIOUS FOOD PRODUCT)

WHEREAS, the Department of Education, Dagupan City Division is in need of a supplier for the IMPLEMENTATION OF SCHOOL-BASED FEEDING PROGRAM (SBFP) FOR FY 2023 (NUTRITIOUS FOOD PRODUCT);

WHEREAS, the **Approved Budget for the Contract (ABC)** which is funded by the Government of the Philippines (GOP)–General Appropriations Act (GAA) FY 2023 through the Department of Education is **Seven Million Five Hundred Forty-One Thousand Four Hundred Twenty-Four Pesos (Php 7, 541, 424.00)**;

WHEREAS, the BAC through its Secretariat posted the Invitation to Bid at the PhilGEPS portal with Reference No. 9905615, at the Division website and at the conspicuous places of the Division Office on July 7, 2023;

WHEREAS, a Pre-Bid Conference was held on July 13, 2023 at the Division Training Center, DepEd Dagupan City and was attended by observers and prospective bidders;

WHEREAS, the Submission and Opening of Bids was held on July 27, 2023 at the Division Training Center, DepEd Dagupan City with One (1) bid proposal;

WHEREAS, only one (1) bid proposal passed the eligibility requirements after thorough examination of its technical and financial bid documents;

WHEREAS, the Technical Working Group (TWG) conducted a Detailed Bid Evaluation and Post Qualification Evaluation on July 27, 2023 and August 8, 2023 respectively;

WHEREAS, on August 7, 2023 and August 10, 2023 respectively, through BAC Resolution No. 2023-0043-A and No. 2022-043-B, the committee adopted and confirmed the TWG Detailed Bid Evaluation Report declaring NUTRIDENSE FOOD MANUFACTURING CORPORATION as the bidder with the Single Least Calculated and Responsive Bid;

WHEREAS, the committee concluded to declare **NUTRIDENSE FOOD MANUFACTURING CORPORATION** as the single least calculated and most responsive bidder;

NOW, THEREFORE, we the members of the Bids and Awards Committee hereby resolve, as it is hereby resolved to recommend the award of contract to **NUTRIDENSE FOOD MANUFACTURING CORPORATION** for the **IMPLEMENTATION OF SCHOOL-BASED FEEDING PROGRAM (SBFP) FOR FY 2023 (NUTRITIOUS FOOD PRODUCT)** with the contract amount of **Seven Million Five Hundred Forty-One Thousand Four Hundred Twenty-Four Pesos (Php7,541,424.00)**.
