- 2. The functions of the BSK-ETF members include, but are not limited to the following:
  - a. Maintain an Operation and Monitoring Center to document and report all teachers and school-related issues and concerns before, during, and after elections;
  - b. Ensure that teachers are provided with and/or referred to adequate information technical, and legal assistance in the course of the perfomance of their duties as members of the Electoral Board;
  - c. Serve as DepEd institutional link to volunteer organizations and individuals;
  - d. Provide close horizontal and vertical coordination and consultation amond DepEd, COMELEC, and partner agencies involved in the 2023 BSKE; and
  - e. Complement the other government agencies' efforts for an honest, orderly, and peaceful elections.
- 3. Further, the DepEd, Schools Division Office at Burgos St. Pob. Oeste, Dagupan City shall also serves as its Command Center during the duration of their election duty.
- 4. The duty of the Division Election Task Force (DETF) will start at 1:00 p.m. of October 29, 2023 and ends on 12:00 noon of October 31, 2023.
- 5. The DETF shall be entitled to overtime pay, subject to availability of funds, or in lieu of OT Pay, Compensatory Time-Off of not exceeding 15 working days in accordance with existing Civil Service Rules and Regulations
