A RESOLUTION **DECLARING SINGLE LEAST CALCULATED RESPONSIVE BIDDER AND RECOMMENDING APPROVAL OF AWARD TO FIVE ED PRINTING PRESS FOR THE REPRODUCTION OF SENIOR HIGH SCHOOL SELF-LEARNING MODULES FOR QUARTER 1 (1ST SEMESTER AND QUARTER 2 (2ND SEMESTER) of SDO DAGUPAN CITY**

WHEREAS, the Department of Education, Dagupan City Division is in need of a supplier for the REPRODUCTION OF SENIOR HIGH SCHOOL SELF-LEARNING MODULES FOR QUARTER 1 (1ST SEMESTER AND QUARTER 2 (2ND SEMESTER) of SDO DAGUPAN CITY;

WHEREAS, the **Approved Budget for the Contract (ABC)** which is funded by the Government of the Philippines (GOP)–General Appropriations Act (GAA) FY 2023 through the Department of Education is **Five Million Three Hundred Fifty-Seven Thousand Six Hundred Ten Pesos (Php 5,357,610.00)**;

WHEREAS, the BAC through its Secretariat posted the Invitation to Bid at the PhilGEPs portal with Reference No. 10197807, at the Division website and at the conspicuous places of the Division Office on September 10, 2023;

WHEREAS, a Pre-Bid Conference was held on October 17, 2023 at the Division Training Center, DepEd Dagupan City and was attended by observers and prospective bidders;

WHEREAS, the Submission and Opening of Bids was held on November 6, 2023 at the Division Training Center, DepEd Dagupan City with One (1) bid proposal;

WHEREAS, One (1) bid proposal passed the eligibility requirements after thorough examination of its technical and financial bid documents;

WHEREAS, the Technical Working Group (TWG) conducted a Detailed Bid Evaluation and Post Qualification Evaluation on November 6, 2023;

WHEREAS, on November 6 & 15, 2023 through BAC Resolution No. 2022-0100-A and No. 2022-0100-B, the committee adopted and confirmed the TWG Detailed Bid Evaluation Report declaring FIVE ED PRINTING PRESS as the bidder with the Single Least Calculated and Responsive Bid;

WHEREAS, the committee concluded to declare **FIVE ED PRINTING PRESS** as the single least calculated and most responsive bidder;

NOW, THEREFORE, we the members of the Bids and Awards Committee hereby resolve, as it is hereby resolved to recommend the award of contract to **FIVE ED PRINTING PRESS** for the **REPRODUCTION OF SENIOR HIGH SCHOOL SELF-LEARNING MODULES FOR QUARTER 1 (1ST SEMESTER AND QUARTER 2 (2ND SEMESTER) of SDO DAGUPAN CITY** with the contract amount of **Five Million Three Hundred Forty-Eight Thousand Five Hundred Ninety-Three Pesos (Php 5,348,593.00)**.



CONTRACT AGREEMENT

THIS AGREEMENT made the 5th day of December 2023 between **DEPARTMENT OF EDUCATION, SCHOOLS DIVISION OFFICE DAGUPAN CITY** of Dagupan City, Pangasinan (hereinafter called "the Entity") of the one part and **FIVE ED PRINTING PRESS** of Lucao, Dagupan City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **REPRODUCTION OF SENIOR HIGH SCHOOL SELF-LEARNING MODULES FOR QUARTER 1 (1ST SEMESTER AND QUARTER 2 (2ND SEMESTER) of SDO DAGUPAN CITY** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Five Million Three Hundred Forty-Eight Thousand Five Hundred Ninety-Three Pesos (Php 5,348,593.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Five Million Three Hundred Forty-Eight Thousand Five Hundred Ninety-Three Pesos (Php 5,348,593.00)** or such other sums as may be ascertained, **FIVE ED PRINTING PRESS** agrees to **REPRODUCTION OF SENIOR HIGH SCHOOL SELF-LEARNING MODULES FOR QUARTER 1 (1ST SEMESTER AND QUARTER 2 (2ND SEMESTER) of SDO DAGUPAN CITY** in accordance with his/her/its Bid.


