
**ESTABLISHMENT OF DEPED REGION 1
POOL OF TECHNICAL OFFICIALS**

To: Schools Division Superintendents
Chiefs, Schools Governance and Operations Division
Division Sports Officers

1. In support of the Department of Education's (DepEd) commitment to enhancing the quality of the Palarong Pambansa, particularly in the management and conduct of its featured sports competitions, this Office, through the Education Support Services Division, shall establish the DepEd Region 1 Pool of Technical Officials.
2. The aim of the selection process is to:
 - a. Identify teachers and non-teaching personnel with credentials and experience in managing and officiating various sports events;
 - b. Create an updated database of technical officials; and
 - c. Provide equal opportunities to all interested applicants from the fourteen (14) Schools Division Offices.
3. The requirements for applicants are as follows:
 - a. applicants must be 52 years old and below;
 - b. must be a public school teacher or non-teaching personnel; and
 - c. must be physically fit with no history of major medical operations or diseases with comorbidity
4. The documentary requirements include:
 - a. Letter of intent
 - b. Curriculum Vitae
 - c. Documentation of relevant experience in tournament management or officiating (Certificates of Participation/Recognition)
 - d. Training certifications (specialized training for skills development in the chosen sports event)
 - e. Licenses and other accreditation documents (Official recognition from authorized sporting organizations).
5. Incomplete applications will not be considered for shortlisting. Shortlisted applicants will be required to attend the Regional Accreditation of Technical Officials scheduled for this year.
