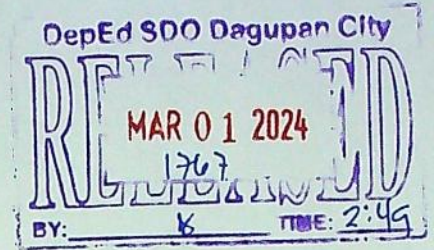

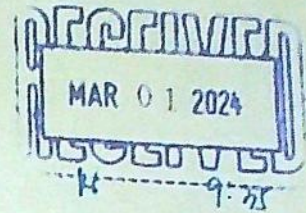


Warm greetings!
