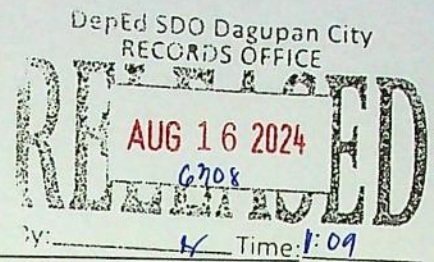

**IMPLEMENTATION OF SCHOOL-BASED FEEDING PROGRAM
(NUTRITIOUS FOOD PRODUCTS and MILK FEEDING COMPONENT)
SY 2024-2025**

1. Pursuant to Republic Act No. 11037 known as **"Masustansyang Pagkain para sa Batang Pilipino Act,"** DepEd Order No. 31, s. 2021 entitled, **"Operational Guidelines on the Implementation of School-Based Feeding Program (SBFP)"**, DepEd Order No. 10, s. 2022- Supplemental Guidelines on DepEd Order No.31, s. 2022, and DepEd Order No.38, s. 2022 -Supplemental Guidelines No. 2 on DepEd order No.31,s. 2022, this office shall implement the School-Based Feeding Program (SBFP) Nutritious Food Products – Milk Feeding Component targeting all kinder and elementary learners identified as severely wasted and wasted.
2. The School-Based Feeding Program (SBFP) Nutritious food Products (149 feeding days). The feeding shall begin simultaneously across all schools from August 19, 2024 until April 15, 2025. Holidays will be included in the counting of feeding days. The Milk Feeding Component consisting of 36 feeding days , shall be implemented from September 2024 to November 2024 to address the nutritional needs of the learners .
3. The program primarily aims to provide fresh milk and ready-to-eat food packs as supplement for underweight learners, develop a milk-drinking habit among the beneficiaries, improve nutritional status and address undernutrition and hunger situation.
4. The Schools Division Office, through Schools Governance Operations Division (SGOD) – School Health Nutrition Unit (SHNU), shall endeavor to collaborate with the Suppliers of Nutritious Food Products and Philippine



Carabao Center (PCC) Island Office for the delivery of fresh milk through a Memorandum of Agreement (MOA) including services for production, quality assurance, processing, packaging, logistics and delivery of fresh milk.

5. Relative to this, all elementary schools shall ensure their readiness to receive, handle and store the NFP and fresh milk which are packed in food-grade polyethylene pouches. Advanced information has been provided to the school heads and coordinators regarding implementation, schedule, mechanics of delivery and receipt by the schools, timelines, storage, handling, accounting, risks management, forms, reporting and recording system, duties and responsibilities & monitoring and evaluation.
