
DepEd Order No. 001 s. 2023, fitled "Revised Designation of Undersecretaries and Assistant Secretaries to their Strands and Functional Areas of Responsibilities and Revised Authorities," and as highlighted in the recently disseminated joint memorandum, OUOPS No. 2023-03-8149 titled, Guidelines on the Supervision and Implementation of the DepEd Career Guidance Program (CGP) for School Year 2023-2024, the Operations Strand, through the Bureau of Learner Support Services-Youth Formation Division (BLSS-YFD), Curriculum and Teaching-Bureau of Curriculum Development (CT-BCD) and the National Educators' Academy of the Philippines (NEAP), collaborate for the implementation and supervision of the CGP related activities, provide quality content for the said program, and lead the training design and delivery of the certification process for the Career Advocates (CAs), including but not limited to the conduct of professional training, assessment, and certification process of teachers and other participants on the CGP to maintain the training standards and quality of delivery.

Through the joint efforts of these three offices, various CGP endeavors have been conducted that gave way to more effective implementation and delivery of the CGP's intended outcomes.

This year, apart from the previous initiatives being done, and in compliance with the requirements of Asian Development Bank (ADB) Secondary School Education Program (SESP) Disbursement-linked Indicator (DLI) 3.3 (i.e., at least-50% of DepEd SSs have two teachers (preferably I male, 1 female) trained, certified and designated as career advocates, the BLSS-YFD, together with BCD-CT, and NEAP will conduct a Training of Career Guidance Program (CGP) Core Team Trainers, with the following details:

- · Phase 2 September 2-6, 2024, in Cavite; and
- Phase 3 October 21-25, 2024, with the venue to be announced.
